



In order to accomplish the baseline goals in this FYE 2021 Budget, we are trusting the Lord for tithes and offerings of approximately \$1,322,000.



Elder Background

Jeff Callender

Jeff Callender was born in Houston, Texas (where he accepted Christ at an early age) and moved to Westfield, NJ, when his father was transferred to this area by Hess Oil (later Amerada Hess). Both he and his wife Joan were raised in committed Christian families, with both sets of parents serving extensively in their respective churches. Jeff and Joan both served in other local churches previously; she as a children's SS teacher, and he in choir, as an adult SS teacher, as Treasurer, and as Chairman of Trustees. Bill Ohnsorg has served as an Elder since 2017.
